- d) Original Character reference from a lawyer of not less than 10 years standing in Ghana. (must be issued this year 2023)
- e) Original Witness Form
- f) <u>Original</u> Application Form
- g) Original Declaration Form
- h) <u>Original</u> Undertaking Form
- i) Clear Photocopy of Valid Photo ID Card (Ghana Card, Passport, Voters ID, Driver Licence)
- j) Evidence of approval for Study Leave from employers (only for working candidates)
- k) Original police report
- I) Gazette / Statutory Declaration on change of name (where the name used to apply for admission is different from the name on the LLB Certificate and Transcript)

Please note that students are admitted in the names on their LLB certificates and transcripts
